### Hawaii Airports Update

Department of Transportation – Airports Division

With the support of the airlines, airport concessionaires, and visitor industry groups, the Airports Division has embarked on a 12-year, \$2.4B statewide **Airports Modernization Program**. The ultimate goal is to transform Hawaii's airports into world-class facilities over the next decade, so they can meet the future needs of residents and visitors alike.

Improvements are extensive. Terminal facilities are being upgraded and selected projects include new and/or renovated concourses, support facilities, parking, and other facilities improvements. These improvements will enhance operational efficiencies, security and the experience of travelers.

Brian H. Sekiguchi has oversight of 15 State-owned airports located on six islands, and they are managed as one Airport System. The System has an annual operating budget of \$250 million and directly employs over 1,200 personnel.

Mr. Sekiguchi will provide an overview of the state's Airports Modernization Program, including current and future projects statewide. The audience will also hear about needs and opportunities that could lead to private-public partnerships on airport properties.
